GENERAL INFORMATION

- WL ZINC/MANGANESE Chelate is a foliar or soil applied micronutrient and is non-phytotoxic when used as directed. It is completely available and absorbed by the leaf surface or the root system because of the natural complexing properties of its phenolic acid chelating complex.

MIXING INSTRUCTIONS

- WL ZINC/MANGANESE Chelate will disperse in water with little agitation. Many pesticides can be added and applied while spraying.

When foliar spraying WL ZINC/MANGANESE Chelate through conventional sprayers, use a minimum of 200 litres of water per hectare. When spraying with low volume equipment, 50 litres of water per hectare is usually sufficient. If less water is used, slight burning of the foliage may occur. A maximum of 5 litres per hectare per application is recommended. Aerial applications should not exceed 1 litre per 4 litres of water. If used as a seed treatment the product can be applied neat or with sufficient water for good coverage.

WL ZINC/MANGANESE is manufactured to rigid controls at the highest possible concentration for effective usage. Any residue in this pail is water soluble.

CAUTION: Always Conduct a "Jar Test" using all products in proper proportion in order to establish physical compatibility.

GENERAL APPLICATION RATES WHEN LEAF & SOIL TEST ARE NOT AVAILABLE

Maintenance application	2 litres per hectare
Moderate deficiency	7-9 litres per hectare
Heavy micronutrient deficiency	9-18 litres per hectare

FOLIAR SPRAY

CROP	RATE	COMMENTS
Vegetables	4 - 6 litres per hectare each spray	Incorporate WL ZINC/MANGANESE Chelate into the normal spray program.
Trees, Fruits and Nuts	4 - 9 litres	If concentrated spray is used, increase the concentration in direct proportion to dilution. If tree crops are sprayed several times a year, the amount can be split into more numerous applications. Split applications are considered more beneficial than single applications.
Field Crops	2 - 5 litres per hectare	Apply recommended rates when plants are young.
Grapevines Inc. Table Grapes	5-9 litres per hectare	Best applied in 2 or 3 applications preflowering.
Seed Treatment Cereal Crops	5-9.5 litres of White Label Chelate per tonne of seed	Can be applied neat or with enough water for thorough coverage.

FERTIGATION RATES

CROP	RATE	COMMENTS
Trees, Vines Horticulture (Soil Treatment)	12 litres per hectare	Apply through dripper or micro-irrigation. Alternatively band under tree/vine row and water in.

LIQUID FERTILISER

Mix WL ZINC/MANGANESE Chelate with liquid fertiliser agitating to thoroughly disperse the trace elements. This can be achieved by adding the product to the mixing batch tank or inducting through a pump. When mixing in batch tank, add product to water or nitrogen solution before adding phosphate material.
