**Potential Health Effects (Acute and Chronic):** Acute: Depending on the duration of contact, overexposure can irritate the eyes, skin, mucous membranes and any other exposed tissue.

### 4. First Aid Measures

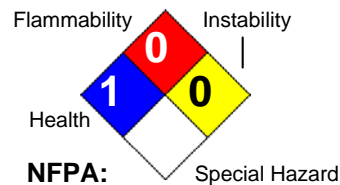
